## Open Book & Board of Review

This is a reevaluation year for property assessments in the Town. The Town Assessor may stop at your property in the next few months; this would be Gene Johnson, Adam Kremer, or John Garlick of Appraisal Services. Questions should be directed to their office at 715-834-1361.

If you question the assessment of your property, the time for you to do something about it is during Open Book. You do not need an appointment. You just come during the hours it is held to speak with the assessor.

If after reviewing your information at Open Book, you believe your property is not assessed fairly in relation to other Town of Washington properties, you must file a written objection form to be heard by the formal Board of Review. Factual evidence must be presented at the hearing.

Open Book and Board of Review dates have not yet been set for 2023, but will be held after Labor Day this year. Watch the Town website or call the office for dates.

### **Elections**

Only request an absentee ballot to be mailed to you if you intend to vote that ballot; absentee voting is our largest expense for an election and we want to be fiscally responsible with the Town tax dollars.

We encourage residents to obtain information regarding voting and elections only from our office or the Wisconsin Election Commission (including the MyVote website); content from other sources are not always accurate.

We welcome questions from any of our residents regarding elections or the process.

A public test of our voting equipment is done before every election. The date and time for testing is posted on our website under Notices a couple weeks before an election. Anyone interested in the process are encouraged to attend.

#### **Upcoming Election**

April 4 - Spring Election

All elections are held at the Town Hall from 7:00 a.m. to 8:00 p.m.

The Town Board Chairman and two Town Board Supervisor positions are up for election on April 4, 2023. Offices are for a two-year term.

**KYLE NYSETH** – I am a retired Naval Officer and a member of the community for 32 years. I am running for the Town of Washington Board Chairman and would appreciate your vote.

### Annexation et al

Annexation is the legal process of transferring property from an unincorporated town to an incorporated city or village. Annexation of property is not new; it has been a part of the town/city tapestry for decades and a topic the Town is acutely aware of. It has been a consideration of the Town Board, the Plan Commission and staff during land discussions, comprehensive planning, and intergovernmental communications and agreements. In recent months, proposed developments and Eau Claire and Altoona aggressive growth efforts have brought this topic to the forefront.

Wisconsin State Statutes define methods to accomplish annexation, two of which we will consider here as they are the most applicable. The historically utilized and most accepted method of annexation is by Unanimous Approval in which a landowner(s) contiguous to a city border petitions the city for annexation. Another method, rarely but more recently employed, is by One-half Approval in which the annexation petition must be signed by a majority of electors in the contiguous annexation territory and either the owners of one-half or the real property in assessed value or in land area. In either case, the approving entity is the City Council; the Town Board has no statutory role in the annexation process. That is the difficult and challenging reality.

As residents, we want the Town to remain healthy and successful. As Town officials and staff members, we share in that desire and vigilantly work towards that end.

### Storm Water Pollution Prevention




What is an ILLICIT DISCHARGE? A discharge to the storm water system (curbs, gutters, culverts, ditches, storm drains) that includes materials other than storm water. Some examples of illicit discharges would include materials from a failing septic system, spilling or dumping, and pipes carrying anything other than storm water that discharges into the storm sewer system. Some discharges that are considered okay and do not require a special permit include land-scape irrigation, residential car washing, fire fighting, uncontaminated ground water pumping, air condition condensation, lawn watering, and other similar discharges.

Why should we care about ILLICIT DISCHARGES? Because the storm water enters the storm water drain system is NOT treated. What goes in the storm drain comes out of a pipe into waterways. It flows directly into area waterways where we swim, fish, and boat. The impacts of such discharges include polluted waterways and harm to wildlife. This would be the case in the Town's more urban area that have curb, gutter and storm drain systems. In rural areas, illicit discharges that enter roads and ditches may not immediately reach a waterway; nevertheless, they pollute the ditch line and may reach a waterway especially when ditches are frozen and little to no infiltration takes place.

What can each of us do regarding ILLICIT DISCHARGES? Do not discharge chemicals, oils or other pollutants into the storm water system which includes roads, conveyances to storm drains and ditches. Be on the lookout and report spills, dumping, pipes carrying pollutants, failing septic systems and the like to the Town office for investigation.

With the spring thaw, agricultural discharges can be of concern as well. As the snow melts it carries with it manure and other contaminates. The typical treatment of infiltration into the ground will not be effective with the frozen ground and can lead to runoff into waterways.

## Raising Poultry

### **Private Wells**

The WI Department of Resources is now accepting applications for treating or replacing private wells with a history of unsafe water from nitrate, E.coli, arsenic, or other contaminants. Applications will be accepted until funding runs out. ## Rest Haven Cemetery

Rest Haven Cemetery is owned and operated by the Town of Washington. For information regarding flowers, wreaths, stone sizes, purchasing spaces, transferring spaces, or scheduling a burial, contact Jackie at 715-834-3257.

Spaces are currently available for \$650.

Winter decorations must be removed from the cemetery before April 1, each year. In the Spring, flowers (real or artificial) can be placed in a plant stand beginning May 1 and must be removed no later than October 15 each year. Anything remaining after this date will be disposed of. Items placed in/on the ground or on a shepherd's hook are not allowed and will be removed.



#### **Dog Licenses**

If your dog does not yet have a 2023 license, payment needs to be made to the Town of Wash-

ington before April 1 or late fees will be applied. In a residential zoning district you are limited to no more than five dogs, unless you have a commercial kennel license.

#### **Real Estate Tax Payments**

If you make installment payments on your real estate taxes the 2nd installment is payable to: Eau Claire County Treasurer's Office at 721 Oxford Avenue, Eau Claire on or before July 31.

## Township Fire Department, Inc. - Station 2

As we come to the end of February the Township Fire Department has not been that busy. Low call volumes are a good thing but with spring around the corner, grass fire season will be upon us. As the snow melts and the vegetation is dead, these are high fire danger conditions. You MUST get a burning permit, and they are only available online at www.townshipfire.org. All the burning regulations can be found on the website as well.

After a long wait, Station 2, Town of Washington will be hosting an in-person fundraiser this year! It will look a little different this year as we balance the workload with staffing issues. Station 2 will be doing a breakfast fundraiser at the Eau Claire County Fair on Saturday, July 29 from 8 a.m.-11 a.m. We will be serve pancakes, sausage, eggs, fruit, milk and coffee; and will have the fire trucks on display.
